Lasting Powers of Attorneys (LPAs)

Did you know your attorney(s) can get an access code for providing to banks and other organisations? Registering online with the OPG this code for a named organisation can be generated so they are able to view a digital copy without the requirement to provide the original or a certified copy. What's on the horizon? It seems there is an increasing requirement for everything to be done digitally, and this is also going to apply to LPAs. The OPG is due to launch a fully digital system for creating and registering LPAs. The aim being to make the process faster, safer, and more accessible. It is expected that there will be hybrid options for those who prefer to do parts of the process on paper and ID verification is going to be required from all parties to the documents to reduce fraud. The OPG are currently developing and testing the new digital system, and we currently have no timescale for the phased rollout at this time. The current paper-based system remains valid and any LPA you have made or make now will still be valid so no need to delay.

This new digital system could create challenges for those who are not comfortable with or untrusting of technology. Keep an eye on our website for updates.

New falls service for Guildford and Waverley residents

If you are registered with certain GP practices in the area, then you will now be eligible for a qualified Community Falls Responder to attend on you if you have a fall. The Responder will attend within 45-60 minutes of your call to help you back up and ensure you are safe and comfortable.

This service is available 7 days a week between 6am-9pm and you must have had a non-injurious fall and be able to weight bear.

The number to make a note of to access this service is 0300 369 0590 and perhaps check with your GP surgery to see if you are in the catchment area.

Finally, we are pleased to advise we now have an AED or Automated External Defibrillator in the office which is available for emergency use. This is a lightweight, easy-to-use medical device designed to help in cases of sudden cardiac arrest. It checks the heart's rhythm and, if needed, sends a controlled electric shock to try and restart it. AEDs are built so that anyone, even without medical training, can use them in an emergency. Let's hope it is never needed but just in case, bear us in mind during office hours.
